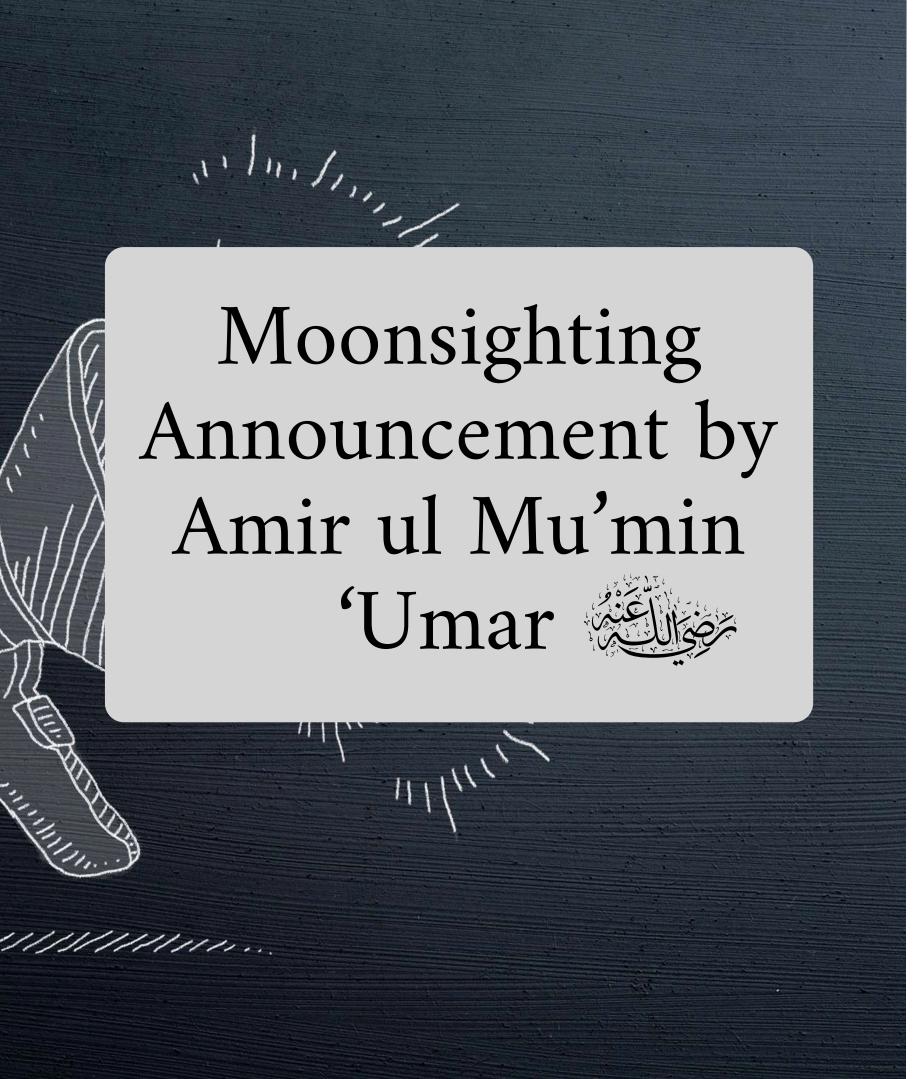
- In the modern world, the task of preserving collective acts of worship is a challenging one, especially for Muslims living in the West as minorities
- Historically, the task of preserving collective a'maal, such as juma'/a'yaad, maintaining bait ul maal, collecting zakah, etc. were all government responsibilities
- Similarly, moonsighting announcements were the responsibility of the Islamic Government (sultan/qadi)
- Once the Qadi/Sultan made the decision, it was binding on all (shar'i daleel)

He said, "Yes." Nabi (ﷺ) then said, "O Bilāl, announce to the people that they should start fasting tomorrow."

It was narrated that 'Abdur-Rahman bin Abi Laila said: I was with 'Umar and a man came to him and said:I have seen the new moon, the new moon of Shawwal. 'Umar said: O people, break the fast...[Musnad Ahmad]

# The Authoritative Rights of Announcing New Moon

شهدوا أنه شهد عند قاضي مصر كذا شاهدان برؤية الهلال في ليلة كذا وقضى القاضي به، ووجد استجماع شرائط الدعوى قضى أي جاز لهذا القاضي أن يحكم بشهادتهما ؛ لأن قضاء القاضي حجة تنوير الأبصار مع الدر والشامي، كتاب الصوم/ قبيل) (مطلب في رؤية الهلال نهارا ج٣ ص٣٥٨

They testified that two witnesses had testified before the Qādi regarding the sighting of the moon on a specific night, and the Qādi ruled accordingly. If the requirements for the testimony were met, the Qādi's ruling is valid; because the ruling of a Qādi is proof.



## A Qadi can only be appointed by a Sultan or one who is authorized by the Sultan

ولا يملك نصب القضاة وعزلهم إلا السلطان أو من أذن له السلطان إذ هو صاحب الولاية العظمى فلا يستفاد . القضاء والعزل إلا منه. والله أعلم الفتاوى الخيرية على هامش تنقيح الفتاوى الحامدية) (ج٢ ص١٧

'The appointment and dismissal of judges is the exclusive right of the Sultān or someone authorized by the Sultān, as he is the one with supreme authority. Therefore, the judicial appointments and dismissals are derived solely from him. And Allāh knows best.'



## A Qadi Appointed by A Non Muslim



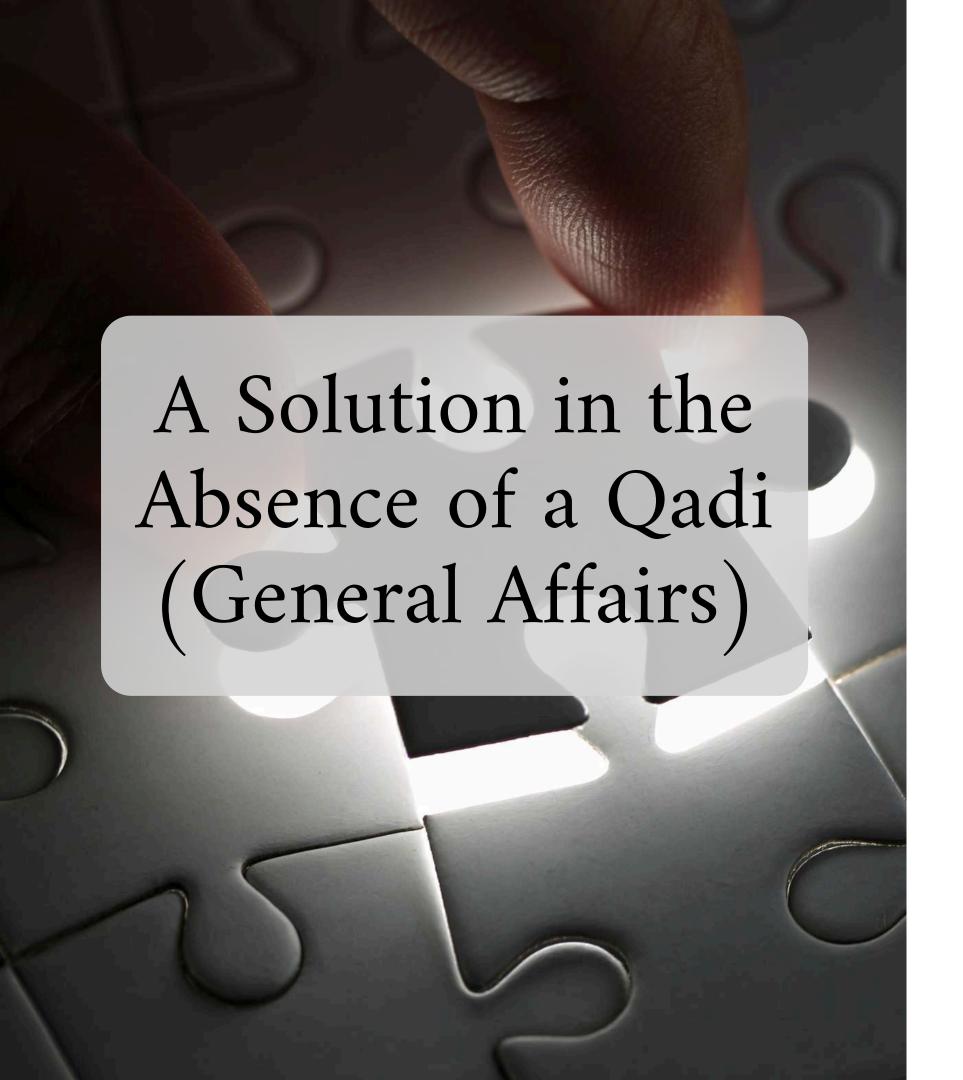
A Qādi's appointment by a non-Muslim is valid if the Muslim community is satisfied with it, and they must also obey his decisions without any doubt.

'If a Qādi is appointed for the Muslims by a non-Muslim and the Muslims are satisfied, then his appointment is valid without any doubt.'

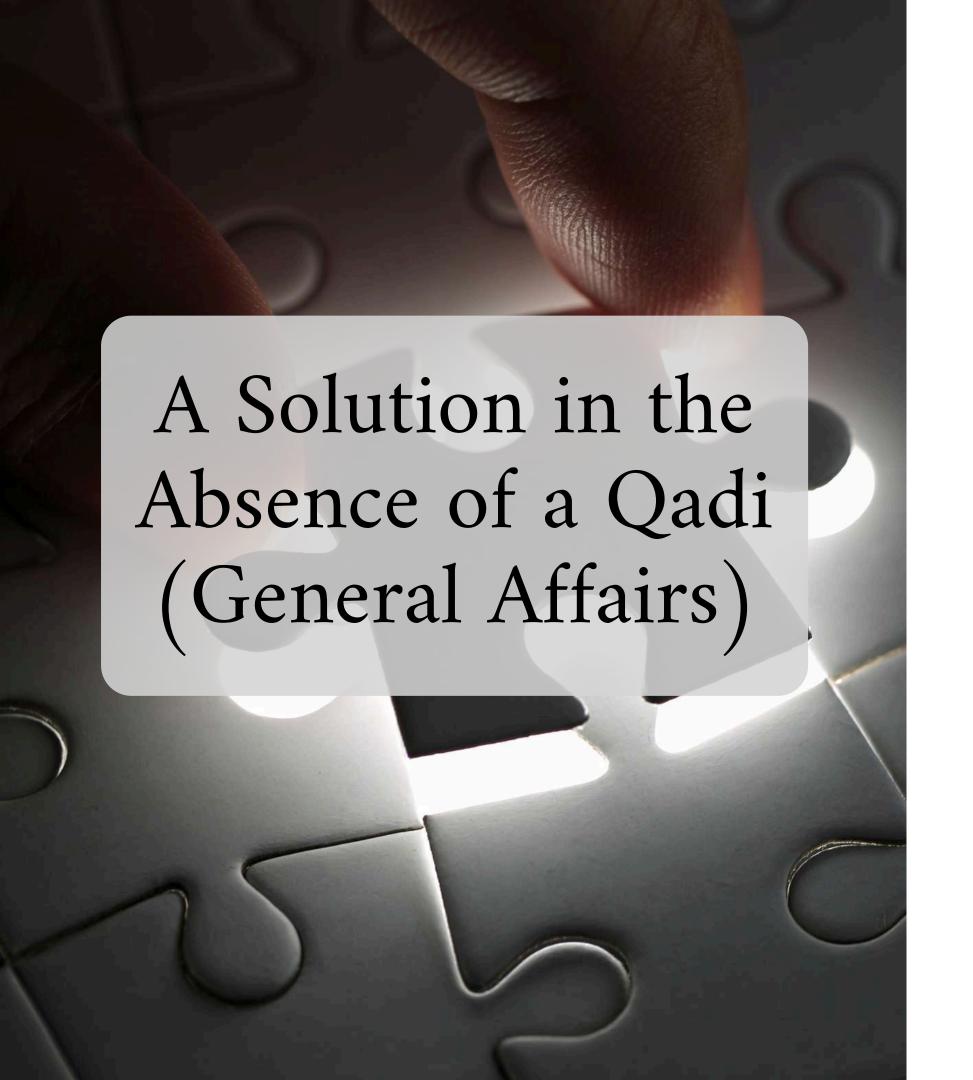
'In every region where a ruler is appointed by them (by non-Muslims), it is permissible to establish the Friday prayers and Eid prayers, and to obey the judges there.'



In the absence of a Qadi (appointed by sultan or by non-Muslim leader), it is crucial that Muslims living in Muslim lands or peacefully in non-Muslim lands appoint a qadi.

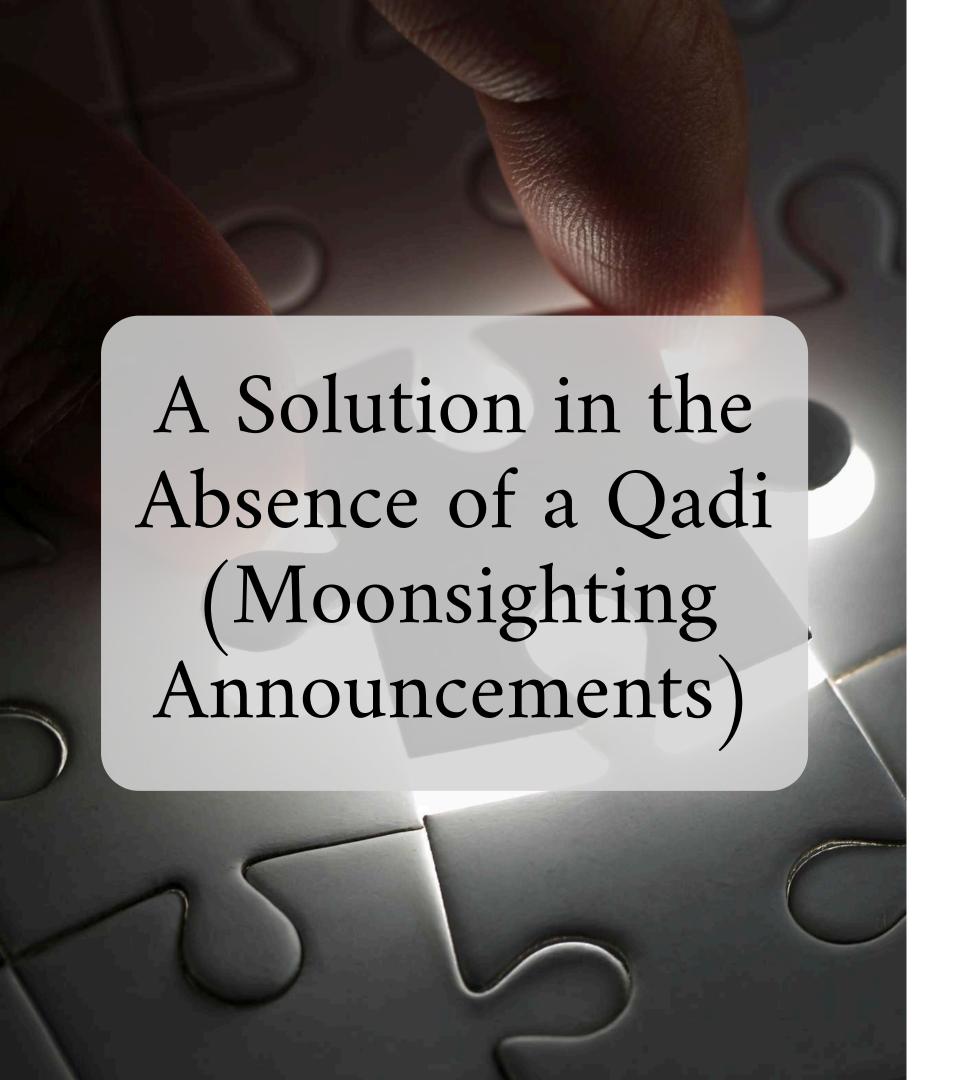
'When there is no Sultān or someone from whom authority can be legitimately delegated, as is the case in some Muslim lands where non-Muslims have gained dominance, like Cordoba in the Maghrib, Valencia, and Abyssinia, and they allow Muslims there to remain by paying tax, then it becomes obligatory for them to agree on one among them to appoint as a leader, who will appoint a judge, or who will himself act as a judge among them.'



In the absence of a Qadi (appointed by sultan or by non-Muslim leader), it is crucial that Muslims living in Muslim lands or peacefully in non-Muslim lands appoint a qadi.

'When there is no empowered ruler to fulfill the Sharia requirements, the responsibility for such matters falls upon the scholars, and it becomes obligatory for the Muslim community to turn to these scholars.'

'If all the Muslims in the country (or their majority) authorize a trustworthy and pious Muslim 'ālim (or a committee of such 'ulamā) to make decisions in all their religious matters, or at least regarding the moon sighting (explicitly or implicitly), then his decision and announcement can also have a universal status.

## Role of a 'Central Hilal Committee' in the Absence of a Qadi

Hazrat also writes in the same book under the title 'In places where the government is non-Muslim, it is necessary for Muslims to appoint their own leader for religious matters'.....

In summary, in a situation where there is no Islamic government and no leader appointed by a non-Muslim government, Muslims themselves should appoint someone as their leader and authority figure so that everyone or at least the majority will submit to his orders. Moreover, considering the essence of this command, it is said that if a trustworthy 'ālim or (a committee of 'ulamā) earns such trust in the country due to his piety, knowledge, and integrity that people unhesitatingly accept his words and fatwas, then he can be given the status of a general authority (at least concerning the announcement of moon sightings).





Faced with the disunity and confusion caused by the lack of a centralized moonsighting authority, and tasked with the responsibility of providing a solution, senior 'ulama from thirteen (13) states gather in 2009 and formed the framework of Central Hilal Committee of North America.



A letter was written to the Darul Ifta of Darul Uloom Karachi, seeking guidance on moon sighting in North America. Mufti Rafi Uthmani (rahimahullah) responded by advising that in such situations, the local community should establish a Central Hilāl Committee or, if one already exists, adhere to its decisions for all moon-related matters. A similar response was given to Muslims in Germany and Canada.

"The matter described in your letter, along with the accompanying documents, has been reviewed. In this regard, the opinion of the Grand Mufti of Pakistan, Mufti Muhammad Rafi Uthmani (rahimahullah), is consistent with what he wrote in response to a question from Germany, which has now been published in the book Navadir al-Fiqh. Similarly, when Muslims from Canada sought guidance from him regarding moon sighting, he wrote an article expressing the same view. Photocopies of both writings are enclosed. In these writings, Mufti Rafi Uthmani suggested that ideally, Muslims in that region should establish their own hilal committee, which would make decisions based on testimonies in accordance with the Sharī'ah. However, if for some reason it is not possible to form such a committee, then they may follow the moon sighting reports from another country. Since a Central Hilāl Committee has been established in your area, has begun its work, and includes a substantial number of scholars, this is undoubtedly a commendable effort that should be further supported." 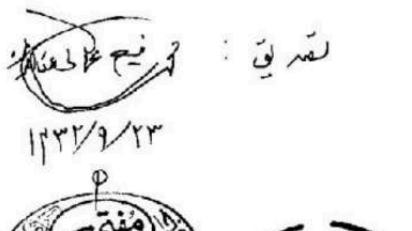

#### History of Moonsighting in America:

- Initially, when Muslims first came to America as immigrants, they followed their countries from back home.
- Later, around the '80s, Islamic organizations formed that carried out moonsighting (ISNA, Chicago Hilal, and others)
- Some of these organizations are still promoting moonsighting until today.
- Others have changed course and follow calculations.

## History of Moonsighting in America, cont.

- In the late 1990's, ISNA changed their criteria and decided that Eid ul Adha would be announced in North America the day after Arafah in Makkah.
- Many international and local prominent scholars rejected this opinion and deemed it invalid.
- In 2002, ISNA retracted this opinion and continued their practice of moonsighting.

#### ISNA's Position on Eid-ul-Adha

ISNA's Position on Eidul Adha Plainfield, IN.,

1/25/2002 (ISNA Headquarter) ::

For the last several years ISNA held the position that Eidul Adha is to be celebrated according to the announcement of Hajj and not according to our local moon sighting as we do for Ramadan and Eidul Fitr. But there were many scholars who criticized this position. They said that this position was not according to the Sunnah. Eidul Adha is to be on the 10th of Dhul Hijjah according to the moon sighting. Muslims in distant lands such as India, Pakistan, Indonesia, Central Asia, etc., have always been celebrating Eidul Adha according to their own moon sighting. There is no report that Muslims waited for the announcement of Hajj or made special effort to find out about the Day of Hajj in order to make their own announcements.

We checked the books of Fiqh, we did not find any support for the assertion that Eidul Adha decision should be made on the basis of Hajj decision. The Hadith of the Prophet - peace be upon him - that "al-Hajj yauma yahujju al-nas" is for those who make Hajj. Of course those who go to Hajj must go to 'Arafah according to the decision of the authorities there, even if that is contrary to the astronomical data or someone's own moon sighting. But people in far away lands do not make Hajj in their locations. They have to make Eid prayer and make Qurbani. They cannot have Eid on 9th of Dhul Hijjah, if the moon was not sighted in their location and sighted in Arabia one day before. They cannot have Udhhiyaha a day earlier.



ISNA's position was under strong criticism from the scholars. No Fiqh Scholar from any country came to the defense of ISNA's position. We have the North American Shura that brings major organizations together. ICNA and Imam Jamil al-Amin's group separated from us last Eidul Adha because of this position. We asked the 'Ulama in Saudi Arabia whether there was a special case for Eidul Adha. Do we have to celebrate Eidul Adha with the Hujjaj? Their answer was that there was no special case for Eidul Adha according to the Shari'ah. If you celebrate your Ramadan and Eidul Fitr according to your own sighting then also celebrate Eidul Adha according to your own sighting. However, if you decide to celebrate Ramadan and Eidul Fitr with Saudi Arabia, then you should also celebrate Eidul Adha with the Hujjaj. They told us that we must be consistent and should not play with this 'Ibadah according to our own desires. There are only two positions recognized in Fiqh: Ittihad al-Matali' (if crescent is sighted in one locality, then all localities should follow it) or Ikhtilafal-Matali' (each locality should see its own moon and decide according to its sighting). The'Ulama' told us that we should adopt one position: either Ittihad al-Matali' or Ikhtilaf al-Matali.' We cannot have both or have one for Ramadan and Eidul Fitr and another for Eidul Adha. There is no basis for this inconsistency in the Shari'ah.

ISNA invited a conference on this subject on the weekend of November 18, 2000. Many scholars presented their papers and after long discussions we came to the decision to change our earlier position. This issue is purely religious and 'ibadah issue and is based on the understanding of Fiqh. If some trustworthy 'Ulama and Fuqaha' prove from the authentic sources of Shari'ah that our earlier position was correct, we shall go back to that position. We must follow what is right and should change ourselves when we know better. May Allah bless all of us to follow the rules of Allah. Wassalam.

### History of Moonsighting in America, cont.

- On August 13, 2006, ISNA adopted the view of the Fiqh Council of North America and declared astronomical calculations as the means of determining the start of Ramadan and Eid.
- There emerged three different ways Ramadan and Eidain were decided:
  - (a) Follow moonsighting
  - (b) Follow the announcement of Saudi Arabia
  - (c) Follow calculations
- In 2006 and the few years following it, there was a lot of discord and disagreement within the American Muslim community

  To attempt to resolve this discord, and keeping in mind the importance and need of a centralized authority, Ulama from 13 states gathers in 2009 in New York to form the framework of Central Hilal Committee...



Based on what was presented and discussed in this conference, the Council issues the following:

Decision # 17/4
Ascertaining beginning of the lunar months

The Council reviewed a number of research papers concerning this issue and after detailed discussions, decided the following:

- Astronomical calculations have become one of the contemporary sciences that attained a high degree of accuracy concerning all that relates to the movements of planets, especially the movements of the moon and the earth, also their positions in relation to the celestial sphere and to each other at any moment of time in a way which is definitive that leaves no room for doubt.
- 2. That the moment of lining up of the sun, moon and earth, or what is referred to as the conjunction is a cosmic point that occurs in one moment. It is possible for the science of Astronomy to calculate that moment with excessively accurate way several years before it occurs. It [conjunction] means the end of the previous astronomical month and the beginning of the following month. Conjunction may occur at any moment, day or night.
- The beginning of the Shar'i new month is ascertained if the following conditions are satisfied:
- 4. First: The conjunction must have actually occurred.
- 5. Second: The moonset follows sunset even by one moment, which marks the beginning of the month. This view was expressed by credible scholars and is consistent with the credible astronomical phenomena.
- Third: The choice of the geographic position of Makkah Al-Mukarramah as the basis
  of the two above conditions.
- Of the beginnings and ends of funal months, experience the months of Part and and Shawwal and to determine such dates in advance so as to help Muslims to perform their acts of worship and their related festivals and occasions, also to regulate their connections with the communities in which they live.
- The council exhorts it members, imams of Masajid and Shari'ah scholars in Muslim societies and other societies to inculcate the culture of respect of what has been concluded by the definitive aspects of astronomical calculation when it is determined

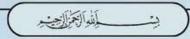
## History of CHC

- 2009: Framework for Central Hilal Committee laid in New York by Ulama from 13 states. Inaugural moonsighting conference.
  - CHC representatives started receiving, verifying and announcing moonsighting decisions for each month under CHC umbrella. Decisions posted on website and spread through phone.
- 2014: 2<sup>nd</sup> National Moonsighting Conference held in Long Island, NY. Ulama from four (4) states joined the effort, totaling 17.
  - Continued joint announcements under CHC umbrella. Twitter account formed and used as an additional platform for announcements.
- 2015: 3<sup>rd</sup> National Moonsighting Conference held in Chicago, Illinois. Ulama from five (5) states joined the effort, totaling 22.
- 2016: 4<sup>th</sup> National Moonsighting Conference held in Chicago, Illinois. Ulama from one (1) state joined the effort, totaling 23.
  - Continued joint announcements under CHC umbrella. WhatsApp messenger added as an additional platform for announcements.
- 2019: 5<sup>th</sup> National Moonsighting Conference held in Stockton, California. Ulama from two (2) states joined the effort, totaling 25.
- 2024: 6<sup>th</sup> National Moonsighting Conference held in Walden, New York. Ulama from two (2) state joined the effort, totaling 27. (this conference)

## CHC Procedures from the 27th to the 2nd

- On the 27<sup>th</sup> of each hijri month, a reminder is sent out from all official CHC platforms (email, Twitter (X) and WhatsApp) encouraging the community look for the moon on the 29<sup>th</sup>.
- For special months, extra encouragement is given (Sha'ban, Ramadan, Dhul Hijjah)
- This reminder includes encouragement to sight, information about the hilal, using text and banners.

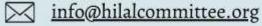

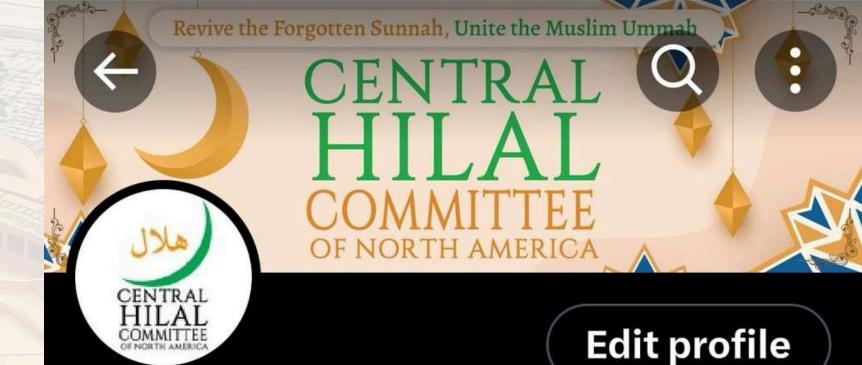
